CHA-CHA JIMENEZ, YLO LEADER, WAS FORCED TO GO INTO HIDING IN AUGUST OF '70 BECAUSE OF \$23 WORTH OF LUMBER. AT THAT TIME REPRESSION WAS COMING DOWN ON THE YLO BECAUSE IT WAS DEALING WITH MAYOR DALEY'S URBAN RENEWAL AND OTHER ISSUES AFFECTING THE POOR COMMUNITY. SOME OF THE EVENTS AND PROGRAMS THE YLO EFFORTS INITIATED WERE: MC CORMICK TAKE-OVER; ALBIZU CAMPOS MARCH; MANUEL RAMOS MARCH; WELFARE MARCHES; "PEOPLE'S PARK"; A FREE HEALTH CLINIC; AND A CONSTANT STRUGGLE AGAINST DALEY'S DUR. THE HIGH POINT OF REPRESSION CAME WHEN CHA-CHA JIMENEZ WAS SENTENCED TO 1 YR. IN JAIL FOR \$23 WORTH OF LUMBER WHILE STILL AWAITING TRIAL ON 9 OTHER CASES. AFTER BEING AWAY FOR 2 YRS. AND 3 MOS., HE HAS DECIDED TO TURN HIMSELF IN TO STATES ATTORNEY, MR. BERNARD CAREY, BECAUSE, AS HE PUT IT, "I WANT TO COME BACK AND BE WITH THE PEOPLE; ENDURE THE HARDSHIPS AND AGONIES WITH THEM; ORGANIZE, FIGHT AND HELP WIN VICTORIES FOR THEM."
