

MINUTES OF THE SEVENTH NATIONAL CONVENTION
OF THE YOUNG SOCIALIST ALLIANCE

DETROIT, MICHIGAN

FEBRUARY 9-11, 1968

First Session, Friday, February 9, 1968 Convened at 1:00 p.m.

I. ORGANIZATION OF THE CONVENTION

 - f. that only those delegates seated at the roll call of a particular session may vote.

I. CREDENTIALS COMMITTEE REPORT

Delegates: Present 49. 31% women and 69% men. Average age 23 years 6 months. Average length of time in the YSA, 2 years and 6 months. 54% students and 46% non students.

Alternates: Present 46. 35% women and 65% men. Average age 23 years and 3 months. Average length of time in the YSA, 2 years and 3 months. 23% students and 52% non students.

Fraternalists: Present 50. 30% women and 70% men. Average age 24 years 5 months. Average length of time in the YSA, 4 years and 6 months. 23% students and 77% non students.

Visitors: Present 197. 109 YSAers, 26 candidates, 72 non YSA. Of those in the YSA, 51½% students and 48½% non students.

General: 342 present, of which 280 are YSAers and candidates. 39% women, 61% men. Average age 22 years and 8 months. Average length of time in the YSA, 2 years 3 months. 14½% from the West Coast, 44% from the Midwest, 37% from the East Coast and 2.4% from the South.

48% students, 52% non students. 43 campuses and 13 high schools represented. Of the non students, 34% employed in skilled trades, 21% employed in clerical, 18% in factory and unskilled, 8% unemployed, 4% professionals and 15% full time political workers. Leading occupations: 15 teachers, 14 printers and 11 in computer field.

Issues that motivated joining the YSA: 105 antiwar movement, 47 colonial revolution and Cuba, 47 black struggle, 38 socialism, in general, 8 independent electoral activity and 6 civil liberties.

Background of those attending the convention: 118 liberals, 50 conservatives, 44 Stalinists, 35 Social Democrats, 20 non political, 18 Trotskyists, 1 Spartacist, 1 Cochranite, 3 left wing Zionists, 1 utopian socialist, 3 Catholic anarchists and 1 John Birch Society.
