Gustie T.'s statement on her abstention: (from voting on Count 4 & on expulsion)

From report of E.C. of comrades of Communist Tendency walk out, I was prepared to vote for expulsion of comrades. I feel this is a violation of party discipline by refusing to recognize the decision of the branch to have E.C. hear charges against them and their defense. At the branch meeting the Communist Tendency reported they were asked to leave the ~~meeting~~ hearings. The proceedings were taped. The voted against ~~playing~~ the tape to clarify what took place on the walk out.

Since this point was disputed and the branch refused to have it clarified by playing this related portion of tape, I cannot truthfully & objectively vote for or against expulsion. To me clarity of charges is important when I ~~am asked~~ to vote to expel any comrade from the party. This is the treatment I would expect from comrades were I on trial.
