

MINUTES OF THE SIXTH NATIONAL CONVENTION OF THE  
YOUNG SOCIALIST ALLIANCE

DETROIT, MICHIGAN, MARCH 24-26, 1967

First Session, Friday, March 24, 1967, Convened at 12:50 p.m.

I. ORGANIZATION OF THE CONVENTION

Presentation of National Committee motions on the organization of the convention by Lew J.

1. Motion: that the Presiding Committee consist of Betsey B., Janet D., Gus H., Doug J., Lew J., Caroline L., Eloise M., Derrick M., Larry S., Melissa S., Peer V., Mary-Alice W.

2. Motion: that procedural questions be decided by majority vote with one speaker for and one against, each with one minute.

3. Motion: that the National Committee recommends to the convention that it not consider the James Eyman document, "Red Guards and White Socialists," to be a counter political resolution for the YSA, and recommends that a point for the discussion of this document not be placed on the convention agenda.

Counter-motion by James E.: that a point for discussion of the Chinese Cultural Revolution be placed on the convention agenda.

- b. that the NC shall be elected by secret ballot.
- c. that delegates and alternates seated in place of absent delegates have voice and vote. That fraternal delegates have voice and consultative vote.
- d. that discussion presentations be limited to ten minutes.
- e. that in any discussion period, no one may speak a second time before each person desiring the floor has had a chance to speak.
- g. that only those delegates seated at the roll call of a particular session may vote.

## III. CREDENTIALS COMMITTEE REPORT

Delegates: Present 42. 24% women and 76% men. Average age 22 years 11 months. Average length of time in YSA, 2 years 6 months. 22% students, 78% non-students.

Alternates: Present 39. 31% women, 69% men. Average age 22 years 1 month. Average length of time in YSA, 1 year 9 months. 41% students, 59% non-students.

Fraternal delegates: Present 41. 34% women and 66% men. Average age 23 years 6 months. Average length of time in YSA, 4 years 7 months. 10% students, 90% non-students.

Visitors: Present 143. 100 YSAers, 43 non-YSAers. Of those in YSA, 44% students, 56% non students.

General: 265 present, of which 217 are YSAers. 36% women, 64% men. Average age 22 years 5 months. Average length of time in YSA, 2 years 3 months. 17% from the West Coast, 47% from the Mid-west, and 36% from the East Coast.

36% students, 64% non-students. 30 campuses and 4 high schools represented. Of the non-students, 33% employed in production and basic industry, 67% employed in clerical, service and technical trades. Leading occupations: 19 on full time assignments, 17 teachers, 11 in computer field, 10 printers, 7 machinists.

74% of YSAers at convention are members of antiwar committees.

Average cost of attending the convention was \$37.00: West Coast, 35 @ \$109.00; Mid-west, 100 @ \$14.00; East Coast, 75 @ \$34.30.

Issues that motivated joining the YSA: 57 antiwar movement, 45 colonial revolution (40 specifically Cuba), 40 Negro struggle, 21 socialism in general, 11 independent electoral activity, 5 civil liberties.
