TO ALL COMRADES

Dear Comrades,

Enclosed are the final fall tour schedules for Linda Jenness and Andrew Pulley. The schedules have been altered slightly since the initial tour mailing was sent out, so comrades should pay special attention to changes which may affect their areas.

In order to facilitate regional organization of the tours, the schedule is devised so that, wherever possible, regional centers assume major responsibility for organizing public engagements for the candidates throughout the region. In these cases, no firm dates have been established for outlying YSA locals, so the centers should make sure to include these locals in their projections for the candidates. The flexibility of this arrangement will allow each region to gain the maximum amount of public exposure for each of the candidates. In certain areas in the West, because of the long distances involved, separate locals must take complete responsibility for organizing the tours in their areas, as the schedules indicate.

Comrades should keep in mind a number of important points about the candidates' tours; for the most part, the following points also apply to the other national campaign tours.

First of all, since rest and travel days have been kept to a minimum, no speaking engagements or other activities should be set up for the candidates on these days.

The candidates should be billed to speak only on those topics for which they will be prepared. These topics are: Vietnam and the '72 Elections, and Nixon's Wage Freeze. In addition, Jenness will be prepared to speak on Women's Liberation as a Force in American Politics, and Pulley on American Politics and the Black Community.

Initial press conferences should be held for each of the candidates as soon as they arrive in each area. Our experiences in the 1968 campaign showed us that these early press conferences netted us large amounts of publicity and helped to lay the basis for working relationships with the local press in many areas.

Both candidates will have extremely hectic and grueling schedules for the duration of the campaign, especially during the months when they are on tour. Comrades should take care to make the candidates' stays in each area as comfortable as possible. Whenever possible, in order to keep travel expenses to a minimum, free food and housing should be provided.

The following financial arrangements will apply for the duration of all of the fall tours:

1) All honoraria obtained for the candidates from colleges, universities, etc., should be sent directly to the National Campaign Committee.

2) Money raised for the campaign while the candidates are in a particular area through banquets and parties (minus expenses), meetings with sympathetic individuals, collections at speeches, etc., should be divided between the National Campaign Committee and the local campaign committee, with the local committee taking 60% and the National Campaign Committee taking 40% of all proceeds.

3) The tour quota is the minimum amount of money that each area is expected to raise for the National Campaign, in order to cover tour expenses. In most areas, we expect to far surpass these quotas.

4) Expenses for travel within a particular region can be deducted from the regional tour quota. For example, if a region has a \$200 quota, but spends \$20 on bus fare for the candidate to get from the regional center to a speaking engagement in a nearby town, then the region will be held responsible for turning in only \$180 to the National Campaign Committee. Accurate records should be kept of all regional travel expenses for the candidates, and other campaign speakers.

5) Any other expenses incurred by the regions in building the tours, such as mailing, phone and publicity costs, must be absorbed by the regions.

6) Proceeds from the tours through each region should be sent to the National Campaign Committee immediately after each candidate's or other speaker's visit terminates. These funds, including the tour quota and any extra money raised, should be sent in along with a completed copy of the enclosed tour report form. No money should be given to the candidates or other campaign speakers.

7) Any questions, etc., relating to campaign finances should be directed to Janet Peace of the National Campaign staff.

Enclosed, along with the final fall tour schedules, are several copies of the tour report forms.

BIOGRAPHY OF CINDY JAQUITH

Cindy Jaquith, 24, is the National Coordinator of Young Socialists for Jenness and Pulley. She is also the National Secretary of the Young Socialist Alliance.

Jaquith attended both Carleton College in Minnesota and Barnard College in New York, and she obtained a B.A. degree from Columbia University in 1969.

She was a leader of the Columbia University student strike in 1968, and was chairwoman of the Columbia Committee to Aid Antiwar GIs in 1969. After graduating from Columbia, she became active in the New York University chapter of the Student Mobilization Committee.

Jaquith became the National Women's Liberation Director of the Young Socialist Alliance in the fall of 1970. She has been active in the New York women's liberation movement and has spoken extensively throughout the country on the topic of feminism.

In the spring of 1971, she toured the Western half of the United States for the YSA, speaking on women's liberation and the revolutionary movement, during which time she visited over 30 cities in 15 states.

Jaquith is a member of the Socialist Workers Party.

BIOGRAPHY OF JOHN HAWKINS

John Hawkins, 23, is a National Coordinator of Young Socialists for Jenness and Pulley, and a member of the National Committee of the Young Socialist Alliance.

He attended Antioch College in Yellow Springs, Ohio, where he helped to found the Antioch College Black Student Union. He also was a founding member of Blacks Against the Draft in Yellow Springs in 1967.

In 1969, he was the Coordinator of the Detroit Third World Solidarity Committee with Vietnam. He also served as Chairman of Afro-Americans for Paul Lodico, the Socialist Workers Party candidate for Detroit Common Council in 1969.

Hawkins served as statewide campaign director for the SWP 1970 Michigan election campaign. He was the SWP candidate for Michigan Secretary of State at this time.

Also in 1970, he was the Detroit Coordinator of the Student Mobilization Committee.

While working as a computer programmer in Cleveland, Ohio, in 1971, Hawkins ran for Mayor of Cleveland on the SWP ticket. He has spoken extensively throughout the country on Black liberation and the revolutionary movement.

He is a frequent contributor to The Militant, the revolutionary socialist newsweekly, and is a member of the Socialist Workers Party.

TO ALL COMRADES

Dear Comrades,

This is to inform comrades of a change which will take place immediately regarding the \$2.00 initiation fee new members pay upon joining the YSA. This initiation fee is set by the YSA Constitution.

The policy has been that all comrades who pay the \$2.00 initiation fee automatically receive a three month subscription to The Militant because \$1.00 of the initiation is used to pay for this subscription.

Upon discussing this policy in the YSA National Office, it was felt that receiving a subscription to The Militant upon payment of the \$2.00 initiation fee should be discontinued.

First, since new YSA members (over 50%) are already subscribers to The Militant, this policy of sending them a second subscription does not serve the intended purpose. Those people who aren't subscribers upon joining would not hesitate to pay \$1.00 or even \$2.00 for a subscription. Also, this would provide a small but added source of income for the YSA to help meet its expanding needs and activities.

From now on, when initiation fees are sent in, it is no longer necessary that it be accompanied by the names and addresses of new members.

All comrades should be informed of this change.

TO ALL ORGANIZERS, NC MEMBERS, AND FINANCIAL DIRECTORS

Dear Comrades,

Attached is the proposed schedule for the fall financial tour which was projected in the Financial Report at the YSA plenum. The objective of the tour will be to discuss the fund drive, campus fund raising, the campaign to stabilize and repay back debts, and the strengthening of regional finances.

Because of the large number of YSA locals and the importance of reaching all areas of the country early in the fall, the tour will primarily cover regional centers. It is essential that all local organizers and financial directors from the region come into the regional center for the tour. Regional organizers should arrange their schedules so that they are present in the centers during this financial tour. In addition, local executive committee members and National Committee members from the locals in each region should make every effort to attend.

One of the main tasks at each stop will be to meet with the organizer and financial director of each local as well as any comrades who are on the National Committee or local executive committee to discuss concretely how the YSA's fall financial campaign can best be carried out in that local. Therefore, it is absolutely necessary that all financial directors remember to bring the locals' books into the center for the tour.


Another meeting which should be arranged is one consisting of all organizers, financial directors, NC members and executive committee members from each region and the regional organizer, traveler, and secretary. This meeting will allow for a full discussion of regional finances and the implementation of the YSA fall financial campaign on a regional basis. In some regions, more than one tour stop is scheduled. Even in these cases, a regional financial meeting should be held in the regional center which should be attended by all organizers, financial directors, and comrades assigned to the regional apparatus.

Regional centers should also make every effort to schedule a local business meeting during the stop, at which an educational on finances and the fall financial campaign can be presented.

The tour schedule provides for only two days in each area, so each stop must be carefully planned well in advance, taking into consideration time for travel. Because of the extremely tight schedule, changes should be proposed only if absolutely necessary. If changes are necessary the YSA National Office should be contacted immediately. This is strictly an internal financial tour so no public meetings should be planned. Travel and rest days have been kept to a minimum and cannot be reduced any further. No meetings should be planned on those days.

The purpose of this tour is to provide better national and regional collaboration for all YSA locals in mapping out and carrying out their plans this fall for the biggest financial campaign in the history of the YSA.
