The industrial arbitration law of New Zealand has been watched by the world as one of the most interesting experiments in the adjudication of disputes between labor and capital. It may still be too soon to pass final judgment on its beneficence, and it may be that opinions concerning its general effect thus far upon trade and industry differ widely. But one point on which there was at first much doubt appears, according to the high commissioner for New Zealand in London, to be pretty well settled. That is the practicability of enforcing the provisions of the law upon workingmen as well as upon their employers. Under the law, disputes as to wages, etc., which cannot be settled by direct negoritation are required to be submitted to a court of arbitration, the decrees of which are binding on both parties—that is to say, on all who have registered for the purpose of being subject to the act. # MANCHESTER, A GREAT

Fine Place for Investment-Labor Is Cheap and Market

Manchester. Eng., May 29.—An American, going home after working five years over here and establishing a large business in such a way that it will take care of itself with an annual visit, said; "Manchester is, in my estimation, the most remunerative center in Europe for investment of American enterprise."

Such testimony is heard frequently. The reason for this is the fact, given recently in a statistical article, that Manchester is situated in the most densely populated area in the United Kingdom.

It is the source of supply, as a port for 171 towns. The district in which these towns are situated is nearer the ocean port of Manchester than any other, is 10,000 square miles in extent, and has a population of about 10,000,000 people.

The area about the Manchester docks, to and from which goods are carted, has a population of 2,000,000 people, supplies for which are drawn from this center.



It generally comes after some sort of an "exosure" of police incompetence, or of criticism of the police board by The majority of those who read of this process applaud it as

means of "rounding up" the criminal population. It is supposed to be a sort of social house cleaning which must be done at certain regular intervals in order to strike terror into the hearts of evil-doers and protect society against its enemies.

If the evil could really be lifted from one of these drag-net hauls

The judge in this case accepted the verdict of the jury.

The case then went to the appellate court and the appellate court reprimanded not only the jury but the judge in the case and sent it back for a new trial.

Here is still another case where the judge in a trial of a personal injury case against this corporation has ruled that the verdict of the jury has not been correct. T. S. Wilson was a cab driver, his cab was run into by a car of the Chicago City Railway and he was made a cripple for life. The case against the company was clear and a verdict in favor of the injured man was evident. The case was given to the jury in the afternoon. The jury stayed out all night and next day it was hung by two members. That day was Derby day at Washington Park. The Chicago City Railway Company controlled Washington Park. That day two members of that jury attended the Derby and occupied boxes. When the lawyers for the injured man made an investigation of the case they found that two men who hung the jury were the men who had attended the Derby.

The judge in this case set aside the trial and granted a new trial but before the new trial came into court the agents for the Chicago City Railway settled the matter out of court for \$1,000. These are but a few of the hundreds of cases in which strange unpre-

cedented things have occured in the jury box when a case against the Chi-

cago City Railway was being tried. It may be chance that such decisions are given by juries in these cases, but there are scores of members of the Chicago bar who have a different explanation of this curious phenomena. The Spanish Dreyfus Case
