# WIRE MEN WILL GO INTO CAMP IF STRIKE COMES

The Chicago telegraphers' strike, which seems imminent, will be conducted along unique lines if present plans mature.

There will be no picketing, no police lines, and, try as it may, the company canout get out an injunction. Provided a suitable location can be found, as mattered to the international executive board for animal as the provided as suitable location can be found, as the opport upon costrable localities, left today for Michigan and Indiana summer resorts. Folkwing their reports some definite action will be taken by the uniton.

Although a radical departure from the usual method of conducting a strike the plan is believed to be practicable and one which will appeal to the men. Tents can be rented for a nominal sum. Bonting, bathing, ishing and general outdoor sports will be indulged in, while the company brings itself to treat with the telegraphers.

Thion officials say the men will welcome a vacation at this time, and, by erecting a camp at which all telegraphers will live charges of violence cannot successfully be made against them. Such a precedure will prevent the company using a corporation's most effective weapon—inflamed public opinion-against its strikers. With the men a hundred or two hundred miles away it will be impossible for Pinkertons to cut telegraph wires and charge violence to the strikers.



The man is George Grey Barnard, one of America's greatest sculptors, according to European critics. Barnard was persuaded by Architect Joseph M. Houston to become sculptor for the Fennsylvania state capitol. He was promised a contract for \$700,000. He mapped out a monumental scheme of statuary for the building.

After he had the work well under way Houston came to him and regretablly saled that the contract must be cut to one-seventh its original figure. Barnard, because he loved his ert, accepted the cut. Then he went to France and engaged an army of workmen to carry out his plans.

The, in spite of his pleadings, Barnard was thrown down by Houston's countermanding the contract. After seging in vain for enough money to bring at least some of his statury to completion, the sculptor was compelled to abandon his undertaking, and the plaster casts of the various groups now are falling into decay in France.

Houston's story was told to the capitof investication committee last week in executive session. It was made public today. It has stirred a volcano of protest among the people, and Governor Stuart is trying to arrange some claim whereby the sculptor shall be compensated as he deserves and his statues, pronounced by French critics the masterpieces of the century, saved.

Will not the penniless man, the strike breaker, the man out of a job and seeking one be made the victim of police activity, while the gambler will be protected? The history of all such crusades, if we may call them such, in the past bears out this contention. The law will be tested, as I have said, on the first case, and we feel confident that it will be declared unconstitutional, as it certainly is. Even the framers of the law know this and have admitted that the definition of a vagrant has been tacked on to a law to regulate present-day evils, even though this definition be one that is fully sixty years old.
