LAW PROHIBITS ADS FOR SCABS

Massachusetts Passes Statute Forcing Bosses to Tell "Strike Is On"

(SPECIAL TO THE DAILY SOCIALIST) Boston, Mass., May 24.—The so-called "strike ad." law becomes operative in Massachusetts Wednesday.

Must Make Strike Known It provides that it shall be obligatory for an employer or his agent who advertises in any manner for workers to state the existence of a strike, lockout or other labor disturbance, if any exists.

Will Aid Unions The trades unionists believe the law will assist them greatly in time of trouble and in inducing the legislature to adopt it.
