SCANDAL FACTS

CHICAGO WARS ON TYPHOID IN **BIG CAMPAIGN**

United States Health Official Is Brought to City By Dr. Evans

The local department of health has temporarily collisted the services of Dr. Leslie Lumsden of the United States public health service in a campaign against typhold. Chlcago already has a low typhoid death rate—only twelve r 100,000 of population in 1909, less than any other large city of the United States-but Dr. Evans is confident that the rate can be much further reduced. He is convinced, moreover, that the education of the public in preventing the presd of typhoid will be an immense aid in dealing with other contaglous diseases.

Educational Campaign

The work done by Dr. Lumsden will be preventive and educational in thar-The main sources of typhoid infection in other cities—bad water and bad milk—have largely been eliminated in Chicago, where the water supply is ly pasteurized. There remains the spread of infection through careless handling of exercts from patients, and especially through files.

The latter get in their deadly work, not only in private homes, particularly in tenement districts and in the neighood of the city dumps, but also at fruit stands, grocery stores and bakeries, where they infect exposed foods. Dr. Lumsden hopes to investigate all cases of typhoid, correct improper conditions where found, and give instruc-tions concerning the care of patients, the disposal of exercts and the exclusion of files. To this end Dr. Lumsden and the health department urge upon physicians and the friends of the sick to promply report all cases of typhoid to the health department. This matter of reporting cases is extremely important, since of course nothing can be done to prevent the spread of infection from unreported cases.

Precautions a Feature

Hints as to diet and other precautions against typhoid will be published in the weekly bulletin of the health de-partment. Some of the main rules are; Boll drinking water and keep same in sterilized vessels; use only certified or pasteurized milk; wash all raw foods before eating; avoid "hokey-pokey" ice cream and all trashy foods; rigorously

exclude flies from your premises.

Dr. Lumsden is chairman of the typhoid hoard of the United States health service, and in this capacity has in-vestigated typhoid and kindred diseases in many parts of the country. He is in Chicago at the instance of Dr. Evans,





UNITED STATES FOOD STUFF EXPORTS FALL OFF

Washington, D. C., July 14. - In statement issued by the bureau of stat-

statement issued by the bureau of statistics of the Department of Commerce and Labor, the exports of staple materials from the United States for the year ended June, 1910, shows a decline all along the line, with the single exception of the value of cotton.

Wheat shows a reduction in quantity under the same period a year ago of 21.000,000 bushels, and in value of \$21.000,000. The decline in value of flour exports is \$5.500,000, of corn \$1.500,000, of meat and dairy products from \$146,000,000 in 1950; to \$110,000,000 in 1910, and 000,000 in 1909 to \$110,000,000 in 1910, and food animals fell from \$18,000,000 in 1909 to \$12,000,000 in 1910.

The gain in cotton exports was caused by a higher market price, the quantity of cotton drepping 1,250,000 pounds, although the value of the cotton exports advanced over \$32,650,00 over the year ended June, 1909.

His employers found that he was pading the pay rolls and had a number of women on the staff who hardly could write their names. Then the employers who had trained him to deceive and rewarded him for lying artistically and serving as a tool for a foul job, ditched him at the height of his prosperity. 

Not in That Way-

The methods of class rule seem never to change. The patricians of ancient Rome kept the plebians quiet by selecting occasional leaders from among the subject class and elevating them to positions of power. No one influence has done more to keep the wage workers contented with their lot than the apparent opportunity that has been dangled before their eyes for a few to rise to the ranks of

The same trick is always played in politics. It is the second stage in the game of deception. The first stage is where the capitalist politician poses as a "friend of labor." Then when the workers begin to show signs of being friends to themselves the next step is taken. Some prominent member of organized labor is selected as a stalking horse. He is placed upon the ticket of the enemies of Labor, and his followers are invited to "vote for a genuine union

Roger Sullivan has just tried this in Chicago. For years this man has been one of the stealthiest foes of Labor. He has acted as the watchdog to round up such of the workers as are willing to bear the Democratic brand and to deliver them to the Republican bosses.

He placed the filthy Busse gang in the city hall by this means. He helped to put Lorimer in congress.

There never was a moment when he was not the most abject tool of every force that is antagonistic to organized labor in Chicago. As the head of the Cosmopolitan Electric company he runs a scab shop, but this is the least of his crimes. It is as the instrument in the hands of those who live by exploiting the workers that he is most dangerous.

Roger Sullivan's political race is approaching its close. His old methods of deception are failing to capture the vote of Labor.

So he now proposes to place union men upon the Democratic ticket, hoping thereby to keep the enemies of union labor in power for a longer time,

We have had one experience along this line in Chicago. We have referred to it before. We shall probably refer to it many times in the future. It is the case of McDermott of the Stock Yards, who was one of Sullivan's political bellwethers by which he called the workers to slaughter. McDermott was a union man. At least he carried a union card. He went to congress. He has been there nearly two years. Only once did he do anything to attract attention to himself. That was when he left the Democratic side of the house to support the bitterest foe of the working class in congress-

The union man who is elected upon a Democratic or Republican ticket has his hands tied, and the ends of the chain are fast to the capitalist chariot. If he submits quietly he only adorns the triumph of his enemy. If he resists he is only dragged in the dirt. In neither case can he do anything for his class.

If Labor wishes to help itself it must HELP ITSELF.

The political parties of capitalism may use laborers but they cannot be used by Labor.

The working class has no need to hitch itself to the corrupt political carcasses of capitalism. It has the votes, the brains, the organizing ability to form its own party.

It has formed such a party in every civilized nation. In proporion as that party has grown has Labor's influence in legislation increased. In proportion as Labor has been enticed away from that party to the political parties controlled by the exploiting class has Labor been politically impotent.

That party is the Socialist party.

I ask for the hospitality of your columns for a brief statement touching the fact that your city authorities summarily denied me the right to discuss Socialism on the streets of Kemmerer. I refuse to believe that every institution in your town is so lacking in fairness and openmindedness on a great public question as your city administration evidently is.

Even the president of the United States has recently given utterance to the statement that the American people must meet the Socialist question. Our party is the largest party of legitimacy in the world, numbering from ten to fifteen million of voters, and more than double this number of followers.

Socialists submit to the world that the basis of all oppression and corruption is to be found in the fact that individuals are permitted to control the bread rights of the people. These bread rights are centered in the land and the machinery of production and distribution. The great means of life have so grown and developed that the holders of the mining and railroad properties and other productive wealth of such vast importance and extent are virtually the owners of the employment or bread right of the workers, and they have no less at their mercy the general public, who must use and consume this form of wealth in their daily lives.

In order to keep the laborer and the general public within their power for purposes of profit, the corporations buy without scruple the press and all sources of opinion within the nation, as well as the governments and courts which makes the laws under which the people

Socialism is only a proposal for a new industrial control.
