### The Inevitable War of the Classes

**Eugene V. Debs on the Class Struggle—Powerful Presentation of the Subject—Clear Distinctions Made—The Economic Basis of Social Institutions Insisted Upon—Socialist Party Organized to Represent the Interests of the Working Class.**

In the present organization of society the character of government is determined by the political party it represents and the party is simply the political expression of the economic interests of the class it represents. For example, the Republican party is essentially the party of the large and successful capitalist class; the Democratic party is of the smaller struggling and less successful capitalists, who in large measure consist of the middle class of society. The Socialist party is the only party that is or can be truly representative of the interests of the working class, the only class essential to society and the class that is destined ultimately to succeed to political power, "not for the purpose of governing men," in the words of Engels, but "to administer things."

#### The Owning Class the Ruling Class.

The present form of government, based solely upon private property in the means of production, is wholly coercive; in Socialism it will be purely administrative. The only vital function of the present government is to keep the exploited class in subjection by their exploiters.

Congress state legislatures and municipal councils as a rule legislate wholly in the interest of the ruling capitalist class. Courts of justice, so-called, decide causes of importance, not upon their merit, but in the interest of the ruling class.

Ministers of the gospel are subject to the same influence and their sermons are moulded to serve the same purpose.

The owning class is necessarily the ruling class. It dictates legislation and in case of doubt or controversy has it construed in its own interest.

Less than forty years ago chattel slavery, a tragic phase in our economic development as well as a necessary part of it, was a perfectly respectable institution. The southern plantation owners practically controlled the government and even the supreme court of the United States was finally compelled to legalize the national iniquity.

Hundreds of able editors consecrated their talents to the perpetuation of the slave traffic. As many ministers of the gospel of Jesus Christ quoted passages from the Scriptures to prove that it was ordained by God Himself.

Statesmen were its tools, journalists its servants, ministers its apologists, lawyers its lackeys.

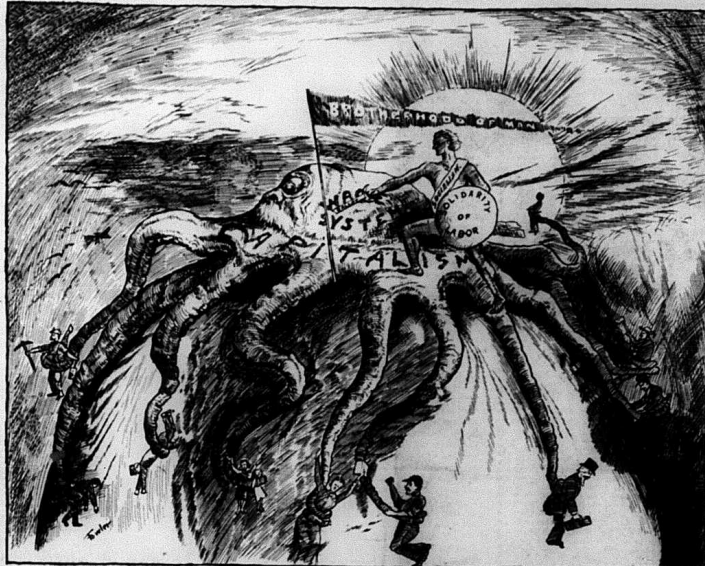
This proves that Karl Marx was right in declaring that the economic basis of society determines the character of all social institutions and in proportion only as this basis changes, the institutions are modified. For instance chattel slavery was legal and respectable as long as it was an economic necessity and no longer. When in the march of the industrial revolution, accelerated so swiftly by the development and application of modern machinery, slavery was overthrown, it became immoral, unjust and disreputable.

In other words it was moral as long as it paid; it became immoral only when it ceased, because of changed economic conditions, to be profitable to the capitalist class.

#### Capitalist Masters and Working Slaves.

What is here said is applicable in every detail to the present wage system in which the man is the servant and slave and at the mercy of another and in which those having antagonistic economic interests are ceaselessly at war, and this accounts for the present strike in Pennsylvania and the hundreds of strikes, boycotts and lockouts which are continually disturbing the

peace of society—and reducing our vaunted civilization to a mere meaningless phrase.

This class struggle will not, cannot cease. It is simply the manifestation of the law of development. All of the forces of evolution are behind it. But for this same struggle in preceding ages human beings would never have emerged from the jungles of slavery.

Through all the centuries of the past man has enslaved and preyed upon his weaker fellow being. For thousands of years there were lords and slaves; through all the middle ages Europe constituted one vast feudal empire, ruled by barons and peopled with their serfs. In the closing years of the eighteenth century, after the feudal system had run its course, its countless and hard suffering victims arose in their might and swept it from the earth. The bourgeois, of which the modern capitalists are the offspring, were installed into power, and under the modifications of the new system the relation between himself and the toiler was changed to the extent that he was called a wageworker and was free to choose his own master. Today we have capitalist masters and working slaves, who, although called sovereign citizens, are exploited of the fruit of their labor as completely under the present system as were their slavish predecessors in the dark centuries of the past.

#### Eighty Per Cent. of Americans Stripped of Their Possessions.

The wage system, like the feudal system, from which it sprang, will fulfill its mission and pass away. Upon every hand we behold the unmistakable signs of decline and decay. Centralization is paving the way to the new society that is evolving from the present economic anarchy.

All capital, by the inexorable law of economic gravitation, will centralize in

the hands of the few.

Already 80 per cent. of the American people are stripped of their possessions and constitute the dispossessed, propertyless class, whose historic mission it is finally, when concentration has completed its course, to dispossess the small possessing class in the name of the whole people.

To accomplish this, especially in the United States where all men (and all women) should have the ballot, political organization is an absolute necessity, and hence the organization of the Socialist party to represent the interests of the working class.

#### Socialists Rely Upon a United Class-Conscious Ballot.

The prevailing economic system can only be abolished in two ways; namely, by securing control of government or by violent revolution. No sane man prefers violent to peaceful measures, and hence Socialists rely upon the efficacy of a united class-conscious ballot to accomplish their end.

But few in number at present, comparatively speaking, their party will as certainly expand to continental and conquering proportions as did the Republican party whose mission it was, as a political organization, to espouse the cause of the black slaves of the Southern states, strike their fetters from their quivering flesh and proclaim by the fiat of its immortal leader, Abraham Lincoln, their emancipation.

#### An Economic Democracy.

The Socialist party is necessarily a revolutionary party in the sense above indicated, and its basic demand is the collective ownership of the means of production and distribution and the operation of all industry in the interest of all the people. This will mean an economic democracy, the basis of the real republic yet to be.

Economic freedom can result only

from collective ownership, and upon this vital principle the Socialist party differs diametrically from every other party. Between private ownership and collective ownership there can be no compromise. As well seek to harmonize fire and water. One produces for profit, the other for use. One produces millionaire and mendicant, the other economic equals. One gives us palaces and hovels, robes and rags, the other will secure to every man and woman the full product of his or her toil, abolish class rule, wipe out class distinction secure the peace of society and make of this earth for the first time a habitable sphere.

### Some Observations.

The bankers who recently met in convention in Seattle were a unit in declaring the nation prosperous, contented and happy, but these fellows do not create wealth, it is their business to set nets to catch the wealth created by the toilers.

Their success in such schemes has caused them to believe the world a bright, joyous place.

One banker said that to be of use to the world is a higher mission than loaning money, but I cannot discover that any steps were taken to set these fellows to doing useful work.

I was greatly impressed with the numerous expressions of keen solicitude for the good of all the people, but I noticed that all practical suggestions were intended to promote the material interest of the bankers.

Expressions of solicitude for the good of the people must have been intended as a sugar coat to insure the hasty passage of laws for the promotion of banking interests. These bankers are oily fellows and they love to see the other man do all the useful work, and so long as he will do it these fellows will use pleasing words and phrases to impress his readers with the idea that when referring to the creator of wealth, it pays the banker to disport himself in this way, and it pleases the worker. Why not continue the game? The banker is willing. Are you?

The state convention of bankers favors the gold standard. Why? Because it is profitable for the same reason. The editor of the Daily, Weekly and Sunday Times tries hard to impress his readers with the idea that he has a mind. He says certain conditions of labor in Seattle impressed his mind. I wonder what the condition of labor all over the earth must do to such a fearful and wonderful mind. If this editor could get his alleged mind to work he might suggest that the toiler is entitled to the entire product of his labor. Such a suggestion would prove a great sensation and might gain the editor some respect. This would be a novel experience for the editor, but he might learn to enjoy truth-telling.

One banker said man's capabilities have been increased a hundred fold, but the workingman in search of a job cannot be made to think that he has benefited in like degree.

All the bankers seem to be in favor of the retirement of the greenback, but they did not urge the retirement of the wage system. It does not seem to be in their way.

Some of the papers are frantically telling how a Mr. Brooks deserted a prosperity job for a tax for the presidency of a college. Well, I suppose Brooks thought there was little danger of making matters worse. I do not blame him for running away from six cents a vote, but he should have to accept the presidency of a college where truth is crucified.

The bankers said in chorus: "Conditions were never better."

The worker says: "It was never harder to live."

There is a difference of opinion between the takers of wealth and the makers of wealth.

One banker said: "A railroad will put us on the map," and then he winked the other eye and looked in the direction of Seattle's slave market. He evidently knows who build railroads.

A banker said: "All shingle mills and logging camps are running full time and the condition is full of hopefulness and courage," but this man takes no chances of losing his life or a hand in converting fir and cedar into commercial products.

"Money is plentiful and the people are prosperous and happy," was the way one parasite stated the matter, but the people who create all wealth get but little of this wealth.

The editor of The Times greatly fears that the striking steel and iron workers of Seattle will suffer irreparable loss by striking business from Seattle. Most working-men are always in light marching order and have little to lose by striking their masters may do. Consequently The Times' appeal is lost on the desert air.

**Convention Notes.**

Call for convention.  
Resolved, That a state convention of the Socialist Party be held in the Seattle Local's headquarters, 120 Virginia Street, Seattle, Wash., Sunday, June 1, 1920, at 10 a. m., for the purpose of nominating candidates for the next state election and transacting such other business as may properly come before it.  
That all members in good standing on June 1, 1920, shall be entitled to take part in the proceedings of the party in convention assembled.  
That any member in good standing on June 1, 1920, shall be entitled to vote by proxy for all matters in good standing on that date who have given him a written proxy; provided, they are members of the same Local as the member representing them.

**IMPORTANT NOTICE TO LOCALS.**  
According to the call for a state convention of the Socialist Party issued by the state committee, only those are allowed to participate who are in good standing on June 1st. In order to facilitate matters, each local should hold a meeting on June 1st and definitely decide who are in good standing and pass upon whatever applications may be before it.  
This rule was made by the State Committee similar to the purpose of having a definite mode of procedure and a uniform rule to apply to all, and hence in case a local finds it impossible to hold a meeting on June 1st, a meeting held within the week following that date will be accepted as a good and sufficient observance of the requirements.  
Immediately after the meeting of the local, the secretary should send to the state secretary a full list of all members in good standing.  
Locals should see to it that dues are sent to state secretary-treasurer if they desire representation in the convention. Locals in arrears for May, 1920, will not be allowed to take part in the convention.  
These matters should be attended to promptly so as to have a full representation as possible. J. D. CURTIS, 1735 Eighteenth Ave., Seattle, Wash., Acting Secretary-Treasurer, S. P.

Whatcom County has been well represented in both the two preceding state conventions. Comrades Cloak, Wallace, Hyde and others of Fairhaven; Lux, Martin, Boston, and others of Whitcom; Edsen and Stark of Lynden; and others of Whatcom, will no doubt try to come.  
Skagit and Snohomish Counties will send Emil Herman, of Lyman, Wm. DeLilly of Arlington, John Graybill of Everett, August Stehr of Granite Falls, Louis Goodman of Snohomish, John G. Smart of Index and many others probably.  
From Pierce County will come Burgess and McClain and Mudgett of Tacoma, Voils and McDougall of Buckley, Black of Palouse, but the list is too long. Martin of Olympia, Neagard of Tumwater, Millette of Aberdeen, Fenlaas of Hopium, Axelson of La Center, Leach of Orford, and so on and so on. There are more of them than we imagined when we started to name them.  
We shall have a notable turnout for Socialism has progressed in the last year in the State of Washington, and is awake as never before.

We almost forgot to mention King County. But we are all here, and need no mention. Come and see us, all you fellow Socialists, far and near.  
The last year for Socialists in the State of Washington has been distinguished by an awakening to self-consciousness. The party has left its infancy and begins to assume individuality, like a growing boy. It is a wide-awake boy, full of blood and fire, token of a splendid future.  
Some of us have been timid about our sharp discussions over party matters. But the boy has only been feeling his muscles and trying their mettle. It is a sign of life and growth. He is getting strong for the fight with the enemy. Watch him fight this time. You watch the enemy as he feels his body blown.

**STATE CONSTITUTION.**  
Article I.—Name.  
Section 1. The name of this party shall be the Socialist Party of Washington, and it shall be affiliated with the Socialist Party of America.  
Article II.—State Committee.  
Section 1. There shall be a State Committee, composed of five members, at least three of whom shall be residents of the place selected for state headquarters, elected by the national organization for the term of one year.  
Section 2. The State Committee shall elect a chairman, vice-chairman, treasurer, secretary, organizer and such other officers or agents necessary to aid in carrying on its work.  
Section 3. The State Committee shall represent the party of this state in its relations with the national organization, organize and grant charters to Locals, call state delegates to national conventions, referendums, vote, receive reports from Locals, arrange circuits for speakers, sell and distribute Socialist literature, file tickets nominated at state conventions and carry on general propagandist work in its district. It shall report semi-monthly to the national committee and publish monthly a financial report, together with the proceedings of the party.  
Section 4. The State Committee shall not publish an official organ. Vacancies in the State Committee shall be filled by a general vote of the members in the state upon nominations made by the party.  
Article III.—Locals.  
Section 1. A Local shall consist of five or more persons believing in the principles of revolutionary Socialism and holding themselves out as members of the Socialist Party of Washington. The officers of a Local shall consist of an organizer, secretary and treasurer and such other agents as may be necessary. They shall be elected the first week in January of each year for the term of one year. Officers elected at any other time shall serve for the remainder of the term. Local officers shall keep the state secretary fully informed as to the names and addresses of local officers and shall report to the State Committee the general condition of the Local the first week in January of each year.  
Section 2. Dues.—Locals shall pay to the State Committee each month a sum equal to 10 cents for each member in good standing, such money to be raised as the Local sees fit.  
Section 3. Any member not in good standing shall take no part in the official proceedings of the party.  
Section 4. Pledge of Members.—All applicants for membership shall subscribe to the following pledge:  
"I, the undersigned, recognizing the class struggle between the capitalist class and the working class, and the necessity of the working class constituting itself into a political party, distinct from and opposed to all parties formed by the propertied classes, hereby declare that I have severed my relations with all such parties; that I endorse the platform and program of the Socialist Party, and hereby apply for admission to membership in said party."  
Section 5. Any member elected to office on the Socialist ticket stands pledged to resign if called upon to support any party or party organization in the state, county or district in which he is elected.  
Section 6. Officers.—Headquarters.  
Section 1. The location of state headquarters shall be decided by the annual convention.  
Article V.—Limitation of Members, Etc.  
Section 1. No member shall accept an office or position under a capitalist party except those provided by law or allowed under civil service rules.  
Section 2. No person shall be admitted to membership in the party who is connected with any party not representing revolutionary Socialism shall thereby cease to be a member.  
Section 3. No person shall become a member of the party who does not sever all connection whatsoever with the capitalist party.  
Section 4. Amendments and Initiative and Referendum.  
Section 1. Any question involving a change in this constitution, a question of party affiliation or the election of any county or municipal official of the Socialist Party or his removal from office, the call to hold special state conventions or any other party matter, shall be submitted to Local Party Committees of the State Committee or by two members of the State Committee.  
Section 2. All questions calling for a referendum vote shall be submitted by the State Committee.  
Section 3. Any question involving a change in this constitution, a question of party affiliation or the election of any county or municipal official of the Socialist Party or his removal from office, the call to hold special state conventions or any other party matter, shall be submitted to Local Party Committees of the State Committee or by two members of the State Committee.

**NATIONAL CONSTITUTION OF THE SOCIALIST PARTY.**

(Adopted in National Convention in Indianapolis, Ind., August 1st, 1901.)  
**ARTICLE I.**  
NAME.  
The name of this organization shall be the Socialist Party, except in the states where a different name has or may become a legal requirement.  
**ARTICLE II.**  
NATIONAL COMMITTEE.  
Section 1. There shall be a National Committee, composed of one member from each organized state or territory, and a quorum of five to be elected from the membership of the locality of the seat of the committee.  
Section 2. The members of this committee shall be elected by and from the membership of the states and territories which they respectively represent by referendum vote. Their term of office shall not be more than two years, and they shall take their seats in the month of January following their election.  
Section 3. This committee shall meet in regular session not often than once a year. Special meetings shall be called at the request of a majority of members of such committee.  
Section 4. Expense of the National Committee in attending meetings shall be paid from the national treasury.

**ARTICLE III.**  
DUTIES AND POWERS.  
Section 1. The duties of this committee shall be to supervise and direct the work of the National Secretary, to represent the party in all national and international affairs; to organize unorganized states and territories; to call national nominating conventions and special conventions called by referendum of the party; to submit questions to referendum; to receive semi-annual reports from the state committees and to make reports to national conventions.  
Section 2. The National Committee shall prepare a semi-annual report of all the financial and other matters of the party and issue the same to all State and Territorial organizations.  
Section 3. The National Committee shall also arrange a system of financial secretaries and treasurers' books for locals, the same to be furnished at cost to locals upon application.  
Section 4. The National Committee shall neither publish nor designate any official organ.  
Another section was adopted by Referendum allowing National Committee upon affiliation of any Local to send speakers.)

**ARTICLE IV.**  
LOCAL QUORUM.  
Section 1. The National Committee shall elect a committee of five to determine the membership of the locality selected for the party headquarters, to supervise and assist the National Secretary as the National Committee shall require, and to be a quorum of the National Committee, but shall be subject to removal at any time by the National Committee. On the question of removal the said local quorum shall have no vote.  
Section 2. Any member of the National Committee not a member of the local quorum may require the National Secretary to submit to a vote of the whole National Committee on the removal of the members of the local committee or the National Secretary, also for its consideration any part of the work of the National Secretary or of the local committee any business belonging to the National Committee.

**ARTICLE V.**  
NATIONAL SECRETARY.  
Section 1. The National Secretary shall be elected by the National Committee, his term of office to be for one year, to begin on the first day of February of each year, beginning with the year 1902. The National Secretary shall be subject to removal at the committee's discretion.  
Section 2. The National Secretary shall be in communication with the members of the National Committee, the officers of the organize States and Territories and with members in unorganized States and Territories. The National Secretary shall receive as compensation the sum of one thousand dollars annually.  
Section 3. The National Secretary shall prepare a monthly statement of the financial and other business of his office, and when approved by the local quorum of five shall issue the same to all party organizations in the same way as the National Committee shall direct.

**ARTICLE VI.**  
STATE ORGANIZATIONS.  
Section 1. Each State or Territory may organize in any way or manner, and under such rules and regulations as it may determine, but not in conflict with the provisions of this constitution.  
Section 2. A State or Territory shall be deemed organized and shall have a right to affiliate upon the organization of not less than four branches, each branch to consist of not less than five members. Each State or Territory so organized shall receive a charter.  
Section 3. The organization of the Socialist Party adopted in convention or by referendum vote, shall be the supreme declaration of the party, and all State and municipal organizations shall be subject to the adoption of their platforms, conform thereto.  
Section 4. In States and Territories in which there is one central organization affiliated with the party, representing at least ten local organizations in different parts of such State or Territory respectively, the State or Territorial organization shall have the sole jurisdiction of all members residing within their respective territories, and the sole control of all matters pertaining to the propaganda, organization and financial affairs within such State or Territory, and the National Committee and sub-committee or officers thereof shall have no right to interfere in such matters without the consent of the respective State and Territorial organizations.  
Section 5. The State committees shall pay to the National Committee every month a sum equal to five cents for every member in good standing within their respective territories.

**ARTICLE VII.**  
HEADQUARTERS.  
The headquarters shall be located at St.
