Massive Verdict of People Against Government Policy

Patna, June 13: The dawnto-dusk Bihar Bandh on 7th June last, called by the Bihar State Committee of the S.U.C.I and other opposition parties was total throughout the State and normal business and life was completely paralysed Such a total bandh had never occurred in Bihar, not even during 1965-66 days when anti-Congressism was at its height and all the left democratic and opposition parties jointly called for State-wide bandhs several times.

In all the districts of Bihar including the State capital. Patna, all shops, big or small, and market places remained completely closed; even roadside small tea stalls and panbidi shops did not open. Vehicular traffic like buses, taxis, rickshaws, tom-toms including Rajya Transport vehicles and trucks did not come out on the streets.

In most of the cities and towns including the State capital, commercial houses, banks, Government offices, courts either remained closed or could not transact any business. A m o n g s t the districts, in Patna, Muzaffar-

pur, Chapra, Purnea, Gaya, the bandh was very intensive, and in Chotanagpur industrial towns, Jharia, Dhanbad, Ranchi, Jamshedpur and Hazaribagh the bandh was unique.

The Bihar Government did not issue any Press communique and preferred to remain silent, as it had no face to deny the reality.

The bandh was called to register protest against the policies of the Central and the State governments which are responsible the for mounting price rise, non-availability of food grains and other essential commodities, water and power crisis, against the anti-people food policy, Police atrocities, fascistic attacks by Government on left parties and democratic movements, police killing of workers, peasants and even leaders like Suraj Babu and others.

The bourgeoise Press in general, including the leading dailies of Patna and Calcutta, although covered the news of the bandh and reported about its total success, vet they played their usual role by not correctly reporting the names of the parties and forces who organised the bandh and made it a massive success. The S.U.C. in Bihar was in the forefront and played a vital role in organising this bandh. Whether in the matter of framing the issues and giving the call for the bandh or in getting other parties to agree to come round it, the State Committee of the S. U. C. performed the leading role. S.U.C. workers in almost all the districts and particularly in Dhanbad, Ranchi, Singhbhum, Muzaffarpur, Chapra and in Patna were found mobilising the people and the shop-keepers, transport men in support of the proposed bandh days before the bandh took place. Rourkela Engineering Workers Score Another Victory

Workers of M/s Zentuc Industries at Rourkela Industrial Estate scored a great victory after prolonged struggle and got all their demands conceded by the management.

The workers, led by the SUC-controlled Rourkela Engineering Workers' Union, affiliated to the UTUC (Lenin Sarani) launched the strike in protest of nonfulfilment of their long standing demands such as regularisation of service, fixation of pay-scale, E. L., C. L., bonus, house rent allowance, overtime wages etc. The management has conceded all the demands.

with the local police, fully armed with guns, pipe guns, grenades, spears, bows and arrows and others lethal weapons made a planned and massive attack on the villagers of Dharmatalla under Canning P.S. in South 24 Parganas. In the course of this attack the raiders have ransacked and looted innumerable houses of workers and supporters of SUC inflicting grievous injury on about fifty persons including four women by gun shots, spears charging etc. and bodily lifted Sri Budheswar Sradar who was injured by bullet. Even now the area remain surrounded by armed rowdies and nobody is being allowed to come out and go into the village.

This pre-planned armed attack on the SUC workers reveals that the ruling party is out to crush the basis of left democratic parties by renewing its fascistic attack on a massive scale.

"We call upon the democratically minded people of the State to be aware of this renewed fascistic attack and organise themselves in democratic movements to cry a halt to this dastardly attack on the very root of democracy.

"We also urge upon the State administration to immediately bring to book all the culprits, seize the licensed and unlicensed guns used against the villagers and ensure normalcy".

New Wave in Peasant Movement of North Bengal

JALPAIGURI

The Jalpaiguri District Conference of West Bengal Krishak and Khet Mazdoor Federation was held with much enthusiasm under the presidentship of Com. Arun Chowdhury, the veteran local leader on the last 2nd and 3rd June at Jalpaiguri.

The open meeting took place on the 2nd June afternoon at the Madrasa Maidan. Thousands of peasants joined the meeting in colourful processions. It was the biggest rally organised in this district since the fascist Congress terror was let loose after the '72 polls and it created much enthusiasm among the local people. Addressing the large gathering, Com. Nihar Mukherjee, W.B State Secretary of SUCI explained how fascism is raising its ugly head under the leadership of Indira Congress in all walks of our life. He also pointed out the incorrect evaluation of the Indira Congress by parties like the CPI and CPI(M) and urged upon the people to build up a revolutionary leadership through united left mass movements.

Com. Subodh Banerjee, member of the Central Committee of the SUCI and President, KKMF, in his long speech unmasked the agrarian policy of the Congress Government and he showed how, starting from land ceiling to land distribution, fixation of taxes and levies, the poor and middle peasants are being exploited and over burdened in the interests of joteders. CPIM MEETING AT MAIDAN SELF-CONTRADICTIONS GALORE

polists, the imperialists and the feudal lords, but the SUC thinks that the stage of Indian revolution is socialist revolution. holding of numerous meetings, street corner propoganda the S. U. C. workers every where mobilised popular support in favour of the bandh. On the day of the bandh, S U. legislators were seen representing before the Congress High Command emissary, who reached Patna on the same day, demanding removal of the Chief Minister from the leadership of State Assembly. Of course, it was just a coincidence bandh had nothing to do with inner-party squabbles of the Ruling Congress. While the people were registering their protest in a massive way against the policies of the ruling Congress—the Congresswallas were busy in drawing their swords against each other for getting a better share of the loaf through ministerial offices.

Com. Pritish Chanda, on behalf of the Bihar State S.U.C.I, has in a Press statement congratulated the people of Bihar for their tremendous response in making the bandh a total success. He said, the bandh has been a massive verdict of the people of Bihar against the Indira Government, both at the Centre and at the State.

Jute Strike Total Admitted even by Labour Ministry

Jute workers in West Bengal observed one-day token strike today in protest against the monthly cut of Rs. 6 from their dearness allowance and curtailment of production by 75%.

The strike call was given by the CITU the UTUC (Lenin Sarani), the AITUC, the UTUC (Bow bazar) and the TUCC. The INTUC opposed it

character of the state machine that is 'trying to preserve the moribund capitalism'? can this state be anything else other than a capitalist state machine? So can it be anything else other than a bourgeois state? If it is a bourgeois state, this bourgeois state is to be overthrown in revolution, which according to the CPI(M) is peoples' democratic revolution in which non big section of the bourgeoisie is an ally. But can any section of the bourgeoisie even if non-big, be an ally in the overthrow of the bourgeois state? Can the bourgeois state be overthrown without overthrowing the entire bourgeois class from the state power? And what will be the stage of revolution in which the entire bourgeois class is over thrown from the state power? Surely it is socialist revolution. Yet the CPI(M) thinks it to be peoples' democratic revolution. So this peoples' democratic revolution of the CPI(M), in reality means not the overthrow of the bourgeois state, but getting into Governmental power through parliament in alliance with a section of the bourgeoisie.

Secondly Promode babu has raised the question "who has overthrown feudalism"? We have elaborately dealt this question previously in various articles published in the previous issues of the Proletarian Era. in booklets and other publications and so we do not like to discuss this issue now; but let us see what the CPI(M) has said about it. Promode babu, himself has written an article in the Ganasakti evening daily supplement published on 7th April 1973 and in the said article he has written that "capitalism has penetrated to the extreme within the peasantry". Promode babu has written this article after the Central Committee session of the

CPI(M), held at Muzaffarpur and in the said session it has been expressed that capitalism has penetrated in the rural relationship. The relevant extract from the Central Committee resolution of the CPI(M) is "As a result of the in roads made by capitalism into agriculture and the agrarion reforms carried out by the bourgeois-landlord Government, certain changes are brought about in the class structure of the rural areas" (Central Committee Resolution on certain Agrarian issues, adopted at its session, Muzaffarpur, March 8.15.'73) How is this penetration of capitalism possible by removing the feudal relation of production? The answer was provided by the Peoples' Democracy, the organ of the CPI(M). In the Peoples' Democracy, dated 28th April 1968 it has been stated—"The big bourgeoisie which headed the national liberation movement and the new independent state after 1947 has been continuously in state power for nearly two decades and has been utilising that state power to immensly strengthen its class position" So it is neither the SUC which has overthrown the feudal relationship of production nor the CPI(M) can re-establish it to prove their fanciful theory of peoples' democratic revolution; it is capitalism which has removed the feudal relation of production and introduced capitalist relation of production in agriculture. Promode babu cited the teachings of Lenin to prove his contention; but such interpretation of Leninism stems from serious indigestion of Leninism, from which Promode babu is seriouly suffering.

Promode babu has stated that the SUC has no programme and explained that in the programme of a communist party is dealt the stage of revolution. At the next moment he said that the

CPI(M) thought this stage as peoples' democratic revolution while the SUC thought this stage as social ist revolution Is this statement not self contradictery? How can Promode babu come to know about the SUC's formulation of the socialist revolution if the SUC has no programme? But unlike the CPI(M), the SUC does not determine the programme every year with newer explanations of the character of the same state. The programme of the SUC was determined in 1948 after thorough analysis of the character of the Indian state and the SUC came to the conclusion about the stage of Indian revolution as socialist revolution. Yet

according to Promode babu the SUC has no programme. Let the rank and file of the CPI(M) ponder how the leaders of their party are trying to mislead them.

Promode babu has taught us another lesson about Marxism. He asserted that the bigness of the meeting of the CPI(M) proved once again that the CPI(M) was in the correct path. If bigness on smallness of a meeting is the yard stick by which the correctness or otherwise of a party is to be judged then the SUC also can claim that as they also held a more or less similar big meeting at the Saheed Minar Maidan on 24th of April last, the SUC is also on the correct path.

W. B. Engineering Workers' Strike

The workers of engineering industry in West Bengal decided to go continuous strike from 16th May to press for the acceptance of their legitimate demands which the engineering industry refuse to concede. The strike call has been given by the U.T.U.C (Lenin Sarani), the C.I.T.U, U.T.U.C (Bowbazar) and the workers unions under T.U.C.C and the unions affiliated to the I.N.T.U.C and H.M.S supported this strike call.

The employers and the Government tried their utmost to frustrate the strike. When the bipartite talks failed, the Government intervened and from 11th May tripartite negotiations between the employers, employees and the Government was initiated.

Sri Sidhartha Sankar Ray, Chief Minister of West Bengal, separately discussed with the employers and submitted a compromise formula which included the proposal for a rise in pay of Rs 20 or slightly more. He also suggested that the proposed strike be deferred for four weeks to continue talks on this formula. Though the leftist trade union Organisations stated above rejected this delaying tactics and were determined in their decission to strike on 16th May, they ultimately deferred the strike by four weeks with a view to maintaining the unity on the face of refusal by the A I T U C and the INTUC, to join the strike from 16th May and declared to stage continuous strike from 16th June if the demands are not met by that period

Torch Procession At Rourkela

A torch procession of 500 cyclists organised by SUCI, Sundargarh Districh Committee paraded the main streets of the Steel Township and Civil Township of Rourkela and all the markets on the evening of May 23, protesting against the price rise and demanding regular adequate supply of essential commodity at cheaper rates.

IN REPLY TO PROMODE BABU'S REMARK AT BOLEPUR MEETING

The CPI(M) and its leaders are at present engaged in maligning the image of the other brotherly and democratic parties of the State. Moreover, in this respect perhaps they are most active in launching slander campaign against our party among others. More often we find that their leaders, in the name of fraternal criticism, actually publicly launch campaign of hate and cannard against us.

There is nothing wrong in criticising the ideology, objectives, attitude and activity of any party, be that party a left and democratic one or even may it be a partner of a joint front. On the contrary, we think it is the bounden duty of a Marxist-Leninist party to launch an ideological struggle against other party or parties whether bourgeosie or petty bourgeoise parties with the communist nomenclature, based on a correct scientific understanding of Marxism-Leninism. We always welcome this sort of criticism from other parties and as genuine followers of Marxism-Leninism we ourselves too make this sort of criticism in regard to the policy, objectives, activities etc. of other parties. We firmly believe that it is only through the pursuit of ideological struggle launched against the reactionary parties of the class enemies of the working class on the one hand, and the social democratic pseudo-communist parties on the other, the genuine Marxist Leninist party would succeed in isolating the pseudo revolution aries, thereby paving the way for the establishment of its ideological hegemony on the people, and would ultimately succeed in defeating the class enemies of the proletariat and in bringing out total revolutionary transformation of the society.

But one thing should not be forgotten that when we criticise any one—whether he is our enemy or a friend or a fellow fighter in a joint front—we should always follow a code of conduct. We think and hope that any left and democratic minded person would agree with us that one should never concoct blatant lies about others with the sole motive of maligning their image. Moreover, one should never put something subjectively in to another's month and then criticise him for that which the latter has actually not uttered.

Not to speak of the Marxist-Leninists, even in the world of the bourgeois democrats, this sort of activities are considered to be utterly unethical and hypocritical too, tantamounting to hineous crimes.

We are shocked to note that our CPI(M) friends are following this sort of unethical line in criticising others in general and our party in particular. They are engaged in criticising certain 'views' and 'stands' in regard to certain issues which they mention as the 'views' and 'stands' of our party which anyone having little k n o wledge about our views would be able to realise to be as complete falsification of our standpoint and views.

Recently, a similar thing happened. In a public meetingheldat Bolepur, West Bengal, on the 28th May last, Mr. Promode Dasgupta, the CPI(M) leader, claimed that the parties like SUCI, RSP etc. lacked any all-India attitude and outlook and it was his party which alone did possess 'such an outlook. In this regard, he referred to our stand on the language problem in Assam and blamed us on the plea that the stand taken by our Assam State Committee on the medium of instruction

issue of that State differed from that of the West Bengal State Committee of our party. This news was published in the Anandabazar Patrika and it has not so far been contradicted. So we may presume it to be the view of the CPI(M).

We would have been happy, if before making such an irresponsible comment he would have taken the trouble of going through the statement made by the State Committee of Assam vis a vis our party's general position in regard to the language issue which has been ventilated in details at various times.

If Mr. Dasgupta would have gone through them then perhaps he would not have dared to make such untruthful observations. But if Mr. Dasgupta has made the said comment even after going through our views on the question of language issue of Assam, then we are forced to comment that Mr. Dasgupta has motivatedly launched a campaign of hate and slander against us with a sinister design. Mr. Dasgupta should note that in whatever ways they might painfully try to malign our party's image before the people, all that they would be able to do would be nothing but the creation of an atmosphere of fanaticism, blind faith, lacking in the spirit of philosophical tolerance among their cadres and ranks that would only help create the breeding ground of fascism.

Let us-see, what we have stated in regard to the issue of language problem in Assam.

When the last language riot in Assam broke out, the Central Committee of our party issued a statement. The relvant portions of the said statement are, "......the Central Committee is of considered view that it is the language policy of the Congress Government at the Centre that is serving as the perpetual breeding ground of communalism, provincialism and such other parochial

feelings on the question of language.....The Central Committee therefore appeals to all the democratic forces and individuals, particularly the students' community in Assam to exert themselves whole heartedly to see that the riots are checked immediately, amity among different communities speaking different languages is restored without delay..... the unity of the people of Assam is preserved and the question of medium of instruction and examination is solved according to democratic norms and principles to the satisfaction of all sections of the people including linguistic minorities in Assam and the adjoining areas outside Assam, but under the educational jurisdiction of the Gauhati University"

(Prol Era, dt. 15th Oct, 1972)

Now the democratic norms and principles that should be observed in regard to the language policy that have been referred to above have been elaborated in details repeatedly at different times. During the period of the last controversy over the language problem in Assam, that led to the communal riot, the Assam State Committee of our party has elaborately discussed these norms and principles published in the same organ of our party. We would like to quote some relevant portions from the said statement. " in the interests of all round improvement of education both in terms of quantity and quality, mother tongue of the taught should be his or her medium of instruction and examination. Assamese must Hence be the medium of instruction and exmination for Assamese speaking students in colleges under the jurisdiction of not only the Gauhati university but other universities as well even outide the state of Assam."

In regard to the problem of the linguistic minorities, it has been stated, "T he s e linguistic minorities love

their respective mother tongues—as the Assamese speaking people love
Assamese—and naturally do not like imposition of
Assamese on them, as the
Assamese people did not like imposition of Bengali language on them......These linguistic minorities must have the right and opportunity of receiving education through their respective mother tongues."

In regard to the medium of instruction in higher education, it has been stated "even when people speaking different tongues will have their respective mother tongues as the medium of instruction and examination, there still will remain the necessity of common link language for the exchange of ideas in the field of higher education.....the link language in the sphere of higher education and higher thought has to be rich, developed, modern languageThe State Committee is of considered view that in the prevailing situation in our country only English can serve as this link language in the sphere of higher education."

In regard to the ruling party's three-language formula, it has been said that, "The State Committee opposes the three-language formula and demands immediate replacement of it by the two-language formula under which a student will have to learn compulsorily only two languages, the first language being his or her mother tongue and the other language English".

Now, any person having slight knowledge regarding our stand on the language problem of our multi-langual country would be able to confirm that the norms and principles mentioned earlier in the statement of the Assam State Committee of our party is neither new and thereby different from nor contradictory to our general all-India policy on the issue

of language problem which has been repeatedly reiterated by the different State Committees of our party including that of West Bengal. It is in complete conformity with our stand on the language problem of vast multi-lingual country. For those readers who are not conversant with our stand, we would like to refer to some relevant portions of our views and observations on the language issue published at different times, in different party organs, in the form of book-

As regard the correct solution of the language problem in Assam, we stated "it can never be forgotten while introducing any regional language of a state as medium of instruction that the linguistic minorities have also legitimate aspiration to prosecute their study in their respective mother tongues. while introducing a regional language as medium of instruction, this legitimate aspiration of the linguistic minorities must be the guiding principle in formulating an all-India language policy.' [Proletarian Era dt. 15.11.72]. In regard to the medium of instruction in higher education, it has been stated' in the same article "it must be admitted that no Indian language at its present stage of developement can readily replace English so far as the higher education is concerned...unless the regional languages develop enough to be able to express the highest thinking in the various branches of knowledge, any attempt to replace English will only hinder the progress of the Indian society. So, along with the introduction of Assamese as medium of instruction with necessary concrete measures for the linguistic minorities to learn through their mother tongues. English should be retained as the medium of instruction in the sphere of higher educa

- (1) English should be common link language as well as the present medium of higher education till the regional languages are not developed to the extent necessary for the propagation of modern intricate thoughts of different branches of human knowledge.
- (2) The medium of instruction and examination in the lower level should be the mother tongue.
- (3) So, while introducing a regional language as medium of instruction, the legitimate aspiration of the linguistic minorities for receiving education in their mother tongues should be properly guarded and fulfilled.
- (4) All possible help should be provided by the State for all-out development of all languages whether developed or undeveloped.

We think that any sensible man would find that the language policy stated by the Assam State Committee of our party is in complete agreement with our all-India policy on language as mentioned above.

Now, we would like to ask the CPI(M) leader Mr. Dasgupta "do you find any contradiction between our all-India language policy and the policy stated by the Assam State Committee of our party?" Of course, Mr. Dasgupta has discovered a contradiction between the two and Mr. Dasgupta is no doubt an honourable man! Again, once he has stated something he cannot change his position, for, he is a gentleman too. But we apprehend that the

left and democratic minded people having little knowledge about the attitude of the CPI(M) in various regional issues might think that the CPI(M), in a vain attempt to cover its own misdeeds is its utmost trying to find fault with the others. Like a man who tries to put his own misdeeds on the shoulder of others, the CPI(M) leaders are attempting to cover their misdeeds by putting blame on the others

The leaders of the party should known that this nasty, unethical tactics ultimately pays no dividend at all. For, you cannot befool all people for all the time and no one can keep his real character masked from the people for a long period.

Mr. Dasgupta and the other bosses of his party should note that Goebbelean tactics gives immediate dividend but ultimately it will pay them back in their own coin.

Lessons of history should not be forgotten; history absolves none.
