### 44th Constitution Amendment Bill

## -ITS REAL IMPLICATION AND THE ROLE OF THE PARTIES

The 45th Constitution Amendment Bill, now renumbered as the 44th Constitution Amendment Bill, was passed by the Lok Sabha a few days back. The ruling party and the bourgeois Press reported with deep satisfaction that the bill finally emerged with 'all support and no opposition' amidst cheers and desk thumping by the Treasury Bench and the Opposition alike. This Amendment Bill is now offered to the people as the foolproof Constitutional safeguard against any attempt to tamper with the democratic rights of the people.

It comes from the hands of those who promised the people before the last Lok Sabha polls to undo the most heinous mischief of Mrs. Gandhi's Government during and her caucas wanted to the Emergency—the 42nd Constitution Amendment. It is now welcomed as restoring 'quite a large number of rights to the Citizens, which were abrogated through the ill-famed 42nd Constitution Amendment during the Emergency' (Ganashakti, Editorial, 25-8-78) by the willing ally of the Janata Party, the CPI(M), which promised the people to fight for scrapping the 42nd Amendment 'lock, stock and barrel'. The 44th Amendment Bill is the ruling party's long pondered and carefully considered replacement for the 42nd Amendment. Its design will ingrained in it is not difficult to decipher. Nor is it difficult to see why the mock heroes of the parliamentary battle-ground who occassionally raised voice during the clausewise reading of the Bill earlier, cheeringly approved it in the final round appreciating warmly the manner in which the Union Law Minister steered the bill. The CPI(M), anticipatedly, fell in line with approval. What does this 44th Amendment Bill seek? According to the ruling party, it seeks 'to correct the distortion of the constitution during the Emergency'. The Statesman comments: 'All in all, even if the 44th Amendment does not fulfil the Janata Party's electoral promise to scrap the 42nd Amendment, it nearly does so. Mr. Samar Mukherjee, the leader of the CPI(M) group in the Lok Sabha,

observed during the Parliamentary debate: 'I welcome this bill, for it takes a big step toward annuling the institutions which Mrs. Indira Gandhi put up through the 42nd Constitution Amendment'. (speech of Samar Mukherjee on the 45th Constitution Amendment Bill, published in Bengali in Ganashakti, 25-8-78, translated by us ). Thus the ruling party, its ally

It is argued by the ruling party that the 44th Amendment Bill restores the people's superiority to the Parliament, leaves the final

## SUCI Decides not to Attend The State Function by **'Left Front' Government**

## Com. Sukomal Dasgupta's Statement

Calcutta, August 30:

Com. ## The Call of 5th August

To the toiling people of India, the 5th of August brings memories steeped in the most profound grief. Two years back, in 1976, the great leader of the proletariat, an outstanding Marxist thinker of this era, Comrade Shibdas Ghosh passed away on this day. Our great leader, teacher, guide and founder General Secretary of our Party himself taught us how the revolutionaries should conduct themselves in their hour of grief, how they should use the occasion to rededicate themselves to the task of forging ahead along the correct revolutionary path to achieve the revolutionary goal. The 5th of August calls upon the toiling people in every corner of the land to pledge themselves to be engaged more and more in the relentless struggle for identifying themselves with the Party and the Revolution in order to be the invincible weapon and the decisive force of history to bring about the emancipation of society from exploitation of all kinds. At numerous Memorial Meetings all over the country, the multitude of our toiling people took the vow to accomplish the revolutionary task which history bestows upon them and fulfil the behest of Comrade Shibdas **Ghosh**. The 5th of August is the occasion for them to pledge themselves to turn their grief into their revolutionary strength.

Reports have been reaching us from all Comrade Shibdas Ghosh, corners of solemn and dignified observance of the Memorial Day under the banner of the Party. A brief coverage of the meetings held on the occasion in some of the States appears below.

### **DELHI**

The Delhi Unit of our Party organised Comrade Shibdas Ghosh memorial meeting on the 19th August at the Constitution Club, New Delhi. Comrade Pritish Chanda, Member of the Central Committee of our Party was the main speaker and Comrade Om Prakas Suman presided. Upholding the teachings of Comrade Shibdas Ghosh, Comrade Chanda explained the revolutionary significance of observing the 5th August. He explained: We have to recall the great revolutionary teachings, and the concrete and living examples of the high revolutionary ethics, morals and culture which

the leader of the proletariat, has bequethed to us. His name will ever shine in the glorious history of mankind for his revolutionary genius in integrating and concretising the general principles Marxism in the concrete conditions of the Indian situation. His unique place in history will also be remembered for further elucidation and elaboration of Marxism and for developing it to a new height in the post-Lenin period.

Comrade Ghosn built up the genuine party of the proletariat in this country, the SUCI, to fulfil the historic task which the so-called communist parties had failed to achieve.

Comrade Chanda analysed, in the light of the teachings of Comrade Shibdas Ghosh, the concrete political situation obtaining at present in our country and pointed out the current tasks facing

us. ## What is Behind the Verbal Duals Between the CPI(M) and Congress-Janata Leaders in West Bengal?

CPI(M) leadership is now engaged in verbal duals with the State Congress and Janata leaders in West Bengal. Both sides accuse each other of violating the norms and fomenting trouble in rural Bengal during this sowing season. CPI(M) leader and chairman of the 'Left Front' Mr. Promode Dasgupta is very much vociferous with brave rhetorics in defence of the share-croppers while his Comrade-in-arms the Chief Minister Mr. Jyoti Basu declares that the "government would maintain rule of law and would not tolerate any forcible land grabbing". Behind this acrimony and apparently contradictory positions of the CPI(M) stalwarts what is the real situation in West Bengal should be carefully noted by all those who feel slightest concern for left politics in our country.

#### CPI(M)'s stance

In a press briefing on 11th August, Mr. Promode Dasgupta, the CPI(M) leader and chairman of the 'Left Front' in West Bengal told the press that strifes were inevitable on land question in the state because the jotedars had grabbed the lands. He further observed that it was not so much important whether there were bloodsheds over land disputes but what was more important an issue was whether the bargadars would get land or not.

Mr. Dasgupta raised the point that out of 35 lakhs bargadars in the state only 8 lakhs could register their rights during Congress rule. According to him another 5 lakhs have been able to do so during the 'front' regime but what would happen to the rest? Besides, there is also the question of returning back those lands which were distributed to the bargadars during the second UF ministry but subsequently grabbed by the jotedars. He, according to press reporting, has said that the principal land problem is concentration of 40% of cultivable lands in the hands of 4% of households. This, he says, is the position after so much land reforms. As such conflicts in the rural side are inevitable. Therefore, Mr. Dasgupta asserts. "Land hunger is a great hunger which has got to be met." Mark the expression of a leader who is supposed to be 'Marxist'!

However, on the face of it, it may appear that Mr. Dasgupta, his party and the 'Left Front' Government of West Bengal want most radical bourgeois democratic reforms in order to advance the cause of the landless and poor peasants. He has also mentioned in this connection the obstacles in the path of these desired reforms by pointing out the adverse role of bureaucracy, police, Congress and Janata Party as also the

profiteer" class. Brave words indeed! But when conflicts and clashes between opposite class interests of the exploiter and the exploited are but inevitable in a class divided capitalist society and that the exploiters would not voluntarily agree to disgorge all the illicit gains they have under their possession or will not refrain from expropriating the exploited, the only course left for the progress of the society is the struggle of the exploited upto the point of revolutionary overthrow of the exploiting class from the state power. This is the ABC knowledge and no Marxism 'Marxist' worth the salt can renounce it. Can Mr. Dasgupta, therefore, disagree if he is a 'Marxist' and if he is true to his words that the only course left for the exploited and oppressed peasantry of the state is to build up mighty united movement even for

these modest reforms to break the wall of resistance of the rural vested interest protected and defended by bureaucracy, police, bourgeois newspapers and the branded bourgeois parties?

One might have expected that Mr. Dasgupta's party and the 'Left Front' Government would move towards this only logical direction especially when all these brave words are coming from the party chief! No, he will be sadly mistaken.

So, when Mr. Dasgupta

the CPI(M) State Secretary is waxing eloquent on the rights of the bargadars and the opposition that is coming from the vested class, bureaucracy, police etc. his comrade in-arms Chief Minister Jyoti Basu convened a conference of the police officials on the eve of the sowing season and instructed them to collect informations about the probable 'vulnerable spots' where trouble might arise, obviously between the jotedars and the bargadars, poor peasants, and prepare accordingly. Mr. Basu is also repeatedly assuring the rural gentry that in case of an'y apprehension of trouble, the government will arrange police pickets "if need be ten such pickets", to their entire satisfaction. The Chief Minister sternly warns that 'rule of law' must not be disturbed and in case of any infringement, police (including EFR and BSF now freely being used) will come down heavily.

The Chief Minister is asking the same police and bureaucracy to look to the interest of the bargadars and poor peasants who according to Mr. Dasgupta play a different role. The Chief Minister asks the bargadars and poor peasants to put faith in the Bloc Committee which was composed, to the only exclusion of our Party SUCI, of the representatives, besides from the front constituents and CPI, from

Mr. Dasgupta calls the representatives of the jotedars as also the BDO-JLRO-OC who are also said to be playing a different role. Not only this, even the poor bargadars of Basanti PS in 24 Parganas who were assured by one of the 'Front' constituents of getting record of rights got bullets instead from the jotedars backed by CPI(M). Similar incidents are taking place in different districts and the 'Left Front' Government under the leadership of 'ironlike' Chief Minister Mr. Jyoti Basu is performing its duty as the guardian of 'law and order' with no less alacrity than that shown by the previous Congress Government. No doubt the bourgeoisie have reasons to be very much pleased with the Chief Minister and his Government.

To those who are politically uninformed and unaware, two things may appear puzzling with apparent contradictions. First, how is it that Mr. Dasgupta being the party chief talks in languages different from those of his Comrade-in-arms, the Chief Minister Mr. Jyoti Basu? Is there any difference between the two leaders? Is it because two having occupied two different positions will have to talk differently? All these questions may appear in the welter of confusions both in CPI(M) Party circles as also in the public. But this is just what the leadership wants to conceal both from the ranks as also the people, their real design. We are coming to

Secondly, if it is a fact that CPI(M) led 'Left Front' Government is in reality serving the rural vested interest then why is there so much hue and cry from Congress, Congress (I) Janata and other known spokesmen of the jotedar and rural vested interest? This is also the part of the game and is therefore intimately connected with the first.

Let us go into the questions. The Janata and Congress leaders are complaining that CPI(M) is

not observing 'rule of law', that they are even violating courts' injunctions and setting up people of their choice as bargadars while evicting those who have been bargadars for long in particular plots or lands and all this.

CPI(M) leader Mr. Dasgupta picks up the issue and speaks heroically about the denial of rights to the bargadars hoping that in the midst of acrimony whipped up nobody would raise the most unpalatable question as to the role and performance of CPI(M) and its peasant's wing in the matter of developing mighty movement of the rural poor and destitute peasants to realise their just demands. He just utilises the situation to show that as all these pro-jotedar parties are opposing them, they surely stand for the bargadars. Mr. Dasgupta and his party should be thankful to the Janata and Congress Leaders!

Why these parties are up against CPI(M)? Does this government in anyway disturb the power structure in the countryside? No. Had it been so one would have seen a different spectacle in the politics of the state. Even during the two UF governments in the past, whatever might have been the weaknesses, unethical conducts and gross opportunism in the role and behaviours of CPI(M) leadership, the tone of the movements set by massive participation of the rural poor in certain distrscts and places caused a fear complex in the circles of jotedars and rural vested interests and they moved in no uncertain manner for the instability of the government. Today the CPI(M) Chief Minister and state secretary claim as their singular achievement that the state is the most peaceful among all other states in India.

Apart from the various pro-jotedar policies and measures of this government, in the last Panchayat election a high percentage of CPI(M) nominees was drawn from the jotedars and rural vested interests

## CPI(M) Tries in vain to cover up its support to Preventive Detention in 44th Amendment

(Contd. from Page 1) atrocities committed on the students in Calcutta, on workers in Santaldih and elsewhere speak the attitude of the CPI(M) led 'Left Front' Government in West Bengal to the democratic legitimate movements of the people. These are the parties who posed themselves as champions of democracy against the autocracy of Mrs. Indira Gandhi and promised the people before the elections that they would fight every inch for restorations, protection and extension of the democratic rights. They wanted people's earn the credentials in this way in order to be installed in the governmental power. Now in power, they are flexing muscles at the slightest hint of discontent and demonstration. At the same time they boast of the so-called constitutional safeguards and restorative provisions in the 44th Amendment Bill. It is plain that these provisions written into the Constitution have no more than paper value in the hand of those who speak of democracy to catch votes, but do not hesitate to resort to anti-democratic and anti-people brutal and repressive measures to safeguard their interest. Judged in this context, the feature of the 44th Amendment Bill that really concerns the people and materially affects them is the provision for Preventive Detention.

When the Janata Government at the Centre had repealed the MISA and withdrawn the Code of **C**riminal Procedure Amendment Bill a few months back, we cautioned the people: ".....it is quite obvious to the toiling people from their concrete experiences that although the MISA has been repealed, the Criminal Procedure Amendment Bill withdrawn and the 45th Amendment introduced, there is hardly any cause for jubilation. The Janata Party has not made any categorical

statement that Preventive Detention will go as a matter of policy and that coercive methods will not be applied against the legitimate democratic movements of the people. Rather the Central Ministers would have the people believe that 'Preventive Detention is not MISA' and they are harping on this tune". (Proletarian Era, 1.6.78) It is now amply clear that things have taken shape as we foresaw them. The former Home Minister, Mr. Charan Singh had made a veiled threat at that time that if the people's protest took the form of organised movement, then the use of extra-ordinary power might become a certainty maintain 'law and order'. The Janata Party however, got a good-performance certificate from its 'Marxist' friends, the CPI(M). Mr. Namboodiripad said that the withdrawal of the Criminal Procedure Amendment Bill marked a victory of the progressive forces within the Janata Party. Mr. Promode Das-Gupta drew a line between the Janata Party and the Congress emphasising that the difference lay in the fact that the Janata Party respected the public opinion as shown by withdrawal of the Criminal Procedure Amendment Bill.

As regards the 44th Constitution Amendment Bill, the CPI(M) has taken essentially the same stand. Of course, this party tells the people that it is not happy over the new Constitutional provision for declaring an internal Emergency if there is an armed rebellion in the country, and that it had moved an amendment in the Parliament to delete this provision. But if the CPI(M) really means it, then why did it not fight tooth and nail against this provision in the Parliament, and why does it not build up a mass movement against the Centre over

## AIDSO Condemns the betrayal of the movement

Comrade K. S. Lamba, Secretary Haryana State Organising Committee has released the following statement to the PRESS on 13. 8. 78:

It is very much deplorable that the dominant group in the leadership of the striking medicos has reached an accord with Haryana Government and has called off the four month old strike.

It is our considered view that the accord reached on 11th August is a complete betrayal of the strike of the students at the alter of sectarian interests which have nothing to do with the interest of the students.

The strike of the medicos started in protest against the police lathi-charge on the 13th April and raised the demand of "non-interference of police in legitimate democratic movements" along with the removal of the V. C. and full "democratisation" of the M.D.U. The re-takeover of Medical College and Hospital by the Haryana Government is an anti-student, antipeople, undemocratic and fascist step. This is a mere transfer of power from an autocratic V. C. to a much more dictatorial government and bureaucratic administration which includes some corrupt elements of the Medical College. This is no solution to the problems confronting the institution. Rather, it will increase and aggravate the problems of students.

The real solution to the problem lies in full "democratisation" of the institution with equal representation from students, teachers, employees and organised social forces and non-interference of Police in the Medical Campus and in ensuring freedom to form and function students' own organisations in the campus.

# Comrade Sukomai Dasgupta Protests Center's Decision to Decontrol Sugar and Restriction on Flood news in West Bengal ON SUGAR DECONTROL

Calcutta, August 18:

"We strongly protest against de-controlling of sugar by the Central Government. We are astonished to find that the Central Government has drawn no lesson at all from the consequences of lifting of inter-state cordoning system imposed earlier on rice and wheat. The present decision will simply lead to a sharp rise in the price of sugar and blackmarketeers and profiteers will be the only ones to benefit from this policy. Increase in price of sugar immediately after the announcement has already substantiated our apprehension.

"We are of the firm opinion that introduction of all-out state-trading in essential commodities alone can ensure regular supply of commodities at a fair price and assure remunerative prices to poor peasants and cultivators.

"We note with deep concern that although the 'Left Front' Government of the State has expressed concern over this decision of the Central Government it has taken particular care so that no effective mass movement can develop against the Government. The State Government has not even taken any effective measures to check this steep price-rise in foodgrains, let alone introducing all-out statetrading in essential commodities.

"While condemning this decision, we demand immediate introduction of all-out state-trading in essential commodities and regular supply of essential items of foodgrain such as sugar, at fair prices and even at subsidized rates, if necessary, keeping in view the lower purchasing power of the people."

### **RESTRICTION ON FLOOD NEWS**

Calcutta, August 24:

"We cannot but wonder at the restrictions said to have been imposed on the local administrative authorities by the State Government regarding supply of informations about flood situation, according to newspaper reports.

"It is reported that the Chief Secretary of the State Government has instructed the local administrative authorities through a circular not to issue any report on flood situation to the Press and the people. According to the said circular only the Chief Secretary has been empowered to release any information regarding the

## COMRADE PRITISH CHANDA Member of the Central Committee of Our Party PRESENTS HIS VIEW AT THE MEETING ON CAMPUS PROBLEM

### Convened by Central Education Minister

Of late, when the student community in the country is bursting forth in discontent over various legitimate demands and student movements are growing in different parts of the country the Janata Government at the Centre and different State Governments are out to supress them branding these as 'indiscipline' and 'lawlessness'. In this background the Union Education Minister recently invited leaders of different political parties in the country to a meeting to discuss the problem of 'indiscipline' and unrest among the students and to devise ways and means to end them. On behalf of our Party, Comrade Pritish Chanda, Member of the Central Comittee, attended the meeting.

Exactly in tune with the previous Congress Government the Union Education Minister of the also present at the meeting. Janata Government, Dr. Pratap Chandra Chandra, held politics to be reponsible for the present student unrest. According to him, students and teachers may have the right to take part in politics outside the educational campus but they should not have it inside the campus. Representatives of other left parties, the CPI(M), RSP and Forward Block, constituents of the 'Left Front' in West Bengal for example, also participated in the discussion. Representatives of the Forward Block and the RSP concurred with the Union Education Minister that politics should not be allowed inside the campus. They also opposed the democratic legitimate demand that 'police must not enter into the educational campus' and 'police must not be used to crash legitimate movements of the students.' Representatives of these parties observed that under the 'changed' context it was not possible to stop police entry into the educational campus. So, they demanded that the right to decide the legitimacy of any student movement should rest with the State Government concerned. They also supported the so-called arguments like 'higher education is not for all' and 'merit should be the criterion for admission' which right from the days of the Congress are being conspiracy to restrict higher values in place of the

education. The CPI(M) General Secretary Mr. EMS Namboodiripad was He assured the Central Government of full cooperation from their side if the government wanted to solve the problem. The formula he put forward to solve the problem laid particular emphasis on allowing representation to students, teachers and guardians in the Senates and Syndicates of the universities but he also added that the government should have the final say in the matter of decision.

On behalf of our Party, Comrade Pritish Chanda drew attention in the first place to the fact that the student unrest in universities and other educational institutions should not be viewed in isolation from the overall socio-economic background of the country. The student unrest is nothing but a reflection of the wide spread discontent of the oppressed masses against the capitalist exploitation in the country. But instead of recognising this objective reality the Janata Government has been striking down with a heavy hand on the spontaneous outbursts and legitimate demands of the students on the plea of 'indiscipline', 'disorder' and 'lawlessness'. In this respect, all the State Governments irrespective of political colour or nomenclature are pursuing the same policy. But none of them care for reorienting the education system on the basis of democratic, scientiadvanced as a cover for the fic and genuine secular

present system carrying the religious and imperialist legacy. This system of education is being continued and conducted with the sole purpose of serving the ulterior class interest of the ruling capitalist class which has been passing it under the name of 'national interest'. For the last twenty years or more the student community has been treated as guinea-pigs for the so-called experiments on syllabus, pattern of education, curriculum and examination system. As a result, the whole education system and the standard is sharply deteriorating and the sphere of education is engulfed in a state of extreme anarchy. Under the circumstances, to point to the students as responsible for the state of affair is not only erroneous but also clearly motivated. By this, the ruling class is simply trying to hide the truth and cover the real problem. Comrade Chanda pointed out that it was strange indeed that the Janata Government and even the 'Left Front' Government came to power the other day through the student movements which are now finding 'lawlessness' in the same. When these leaders were in the opposition, they supported the student movements only to reap benefits or for any other reason whatsoever and the government of Mrs. Indira Gandhi decried the movements as 'lawlessness' and 'indiscipline'. Today, those very parties and leaders are out to suppress brutally the movements while the Congress and Mrs. Indira Gandhiare urging the students to build up movements in the country! Such nasty game of the bourgeois parliamentary politics has been going on in our country. Even if it may appear strange to many, the reality is that the so-called left parties too are now party to this heinous bourgeois parliamentary game of two faced

policy. The leaders of the present government, now after coming to power are not only violating their own minimum promises to the students but are also brutally suppressing the student movements with the help of police and military. They assert that the students must not resort to politics inside the campus. But the question arises if the students are not allowed to take part in politics inside the campus where else would they do so? As social beings the students too have the legitimate right to ponder over the social problems and the country's well being, to conceive and express their opinion and conduct movements to solve these problems. And since they have this right and feel the responsibility they can do it best only inside the campus. So it is ridiculous to question the propriety of their taking part in politics inside the campus. Actually, it is nothing but a conspiracy to destroy student movements in the country which the British imperialists have done, the Congress has done for all these years. And now, the Janata and the so-called left parties try to do the

As some instances of repression of student movements by the police, Comrade Chanda referred to the incidents of brutal oppression of the students in the Rohtak Medical College in Haryana, Vanibihar University in Orissa and the medical students in West Bengal.

In the end, Comrade Chanda said that these facts corroborate that inspite of differences in vocabulary and colour all the State Governments and the Central Governmentwhether the Congress, Congress (I), Janata or the 'Left Front' Government, all are equally eager to demonstrate their capability to ruthlessly put down the legitimate movements of the students and that they all show the same total negligence towards needs and grievances of students. But the legitimacy of the demands raised by the students cannot be questioned in any

way. Comrade Chanda argued that if the government really wanted to solve the problem of student unrest it must take proper steps to meet the following demands:

i) Democratisation of education system i.e. introduction of democratic functioning in the field of education and democratisation of curriculum, syllabus and system of teaching. In place of the present religion oriented education truly secular, universal and scientific education should be introduced.

ii) The present bureaucratic governmental control over the universities and educational institutions must be withdrawn and the relative democracy and independence in education must be restored with due regard.

iii) Police must not be allowed to enter the educational campus and trample its democratic heritage.

iv) While appointing Vice-Chancellor or Administrator in educational institutions, the practice of serving petty party interest must be stopped.

v) The ruling party must not interfere in the autonomous sphere of the universities or educational institutions in its petty party interest.

vi) Curtailing the expenditure of the police budget expenditure on education should be increased.

vii) Restriction higher education on any pretext must go and any such policy and measures must be withdrawn.

viii) The student union election in the Universities and colleges must be made free and fair.

ix) The right of the students to organise demonstrations and legitimate movements must be protected.

x) The demand raised by the 'Left Front' that the right to judge legitimacy of any student movement should rest with the government is totally irrational and undemocratic. So, it cannot be accepted at all.

Notonly this, in a recent pronouncement, public Mr. Dasgupta has exhorted his party men to see the unique opportunity of expanding the party base when the jotedars are losing confidence in their old party Congress and the new one, the Janata.

Congress, Congress (I) and Janata leaders are reacting because CPI(M) is resorting exactly those means, rather with more fineness, to woo the support of the jotedars and rural vested interests which they did or are doing wherever they were or are in power. Congress, Congress(I) and Janata leaders are witnessing that the bulk of the jotedars and rural vested interest are moving from their's to CPI(M)'s fold. This means these parties are fast losing their rural bases in parliamentary politics. This is the reason why these parties are raising so much hue and cry. It is well known in West Bengal that after the rigged election of 1972, Congress evicted large number of share-croppers genuine to induct in their place new ones who could be used as pliant tools at their hands with the help of police, bureaucracy, RG parties and the roughs under their protecting umbrella. By offering jobs to the rural poor at the cost of the old bargadars, Congress served the jotedars doubly by supplying cheap labour who would not revolt as also by breaking the legitimate democratic movements of the share-croppers, landless and poor peasants. Is not CPI(M) following the footsteps of Congress? Is it not also bringing new bargadars in place of the old ones who have been struggling hard to keep

their foothold on plots of lands, for long? Is it not a fact that CPI(M) is trying to deceive the people by this device of induction of 'new' bargadars in place of the old ones by passing it for their fight to record the rights of the bargadars? And in this game, is not this party pressing into service the government machinery-police, bureaucracy and even using the anti-socials as Congress did? It is even trampling upon the settlement records or on the spot enquiries to deprive the bargadars of their rights if they do not support this party. CPI(M) leader is talking loud about the rights of the bargadars but his party men in the districts are giving shield of protection to those jotedar families who have struck deal with the party.

So, it is not a case of sharpening the class battle betwen the jotedars and the oppressed peasantry and CPI(M) taking its position with the latter. It is altogether a different story. CPI(M) as a social democratic party after having tasted governmental power has anchored in the safe parliamentary politics. When in opposition it participated in the democratic movement of the oppressed people from the same ambition in parliamentary politics. Today, after having earned the trust and blessings of the bourgeoisie and having set before it the goal of becoming the third alternative in two-party bourgeois parliamentary design, it is now only interested to cling to governmental power anyhow. It has forsaken the path of mass struggle and is showing its worth to the bourgeoisie even by ruthlessly crushing the democratic movement of the oppressed people. It is now moving to stabilise its position in the parliamentary politics by winning the confidence of the jotedar and vested interests in the countryside just as it has established its rapport with the different chambers of commerce in the industrial field. (Contd. from Page 5) this issue? Which is the genuine safeguard for democratic rights in the bourgeois system? Mass movements or Constitutional amendment? The CPI(M) shows exuberance in praising the Centre for writing into the Constitutional amendment the socalled safeguards for democratic rights, but even a meagre fraction of this energy has not been expended in the faint protest it lodged against the provision for Preventive Dention and Internal Emergency on grounds of armed rebellion. That is why the bill had its final passage in the Lok Sabha 'with all support and no opposition' and the CPI(M) leader Mr. Promode Dasgupta merely expressed 'unhapiness' and no intention to organise mass movement against these most undemocratic provisions written into the Constitution Amendment Bill.

What accommodates all the mock fighters of the parliamentary battle ground in the same boat over the issue of the 44th Constitution Amendment Bill is not difficult to seek. The CPI(M) is trying to emerge as the third alternative on the national plane and vie with the others—the Janata Party, the Congress, the Congress (I) etc.—to thrust itself into the choice of the ruling class in the twoparty parliamentary system now sought to be introduced in this country by the bourgeoisie.
